STOP THE KOREA WAR NOW, DEMAND SWP DELEGATES

NEW YORK, July 19, 1952 — The nominating convention of the Socialist Workers Party today unanimously demanded that "all American troops be immediately withdrawn from Korea."

"This war has taken a toll of over a million and a half victims, including over 120,000 American youth," the convention resolution on Korea stated. "This intervention is part of the program of Washington and the Pentagon to dominate

and exploit all Asia, and to destroy the colonial struggles for independence," the resolution declared.

The Socialist Workers Party convention expressed its "sympathy for the cause of the revolutionary Korean people," and demanded that the Korean nation be indemnified for its losses in the war.

"We further demand," states the resolution, "that all Korean prisoners of war be released without qualification or intimidation."

Minnesota Branch Gives \$500 Boost To Election Fund

The Minneapolis delegation to the 15th National Convention of the Socialist Workers Party gave a \$500 boost to the campaign fund for the presidential election, lifting the total pledged thus far from \$17,500 to \$18,000.

Not to be outdone, the Buffalo delegation announced that prospects look bright around the windy end of Lake Erie for another \$500 there, but definite details about this ante are not yet ready for release.

The new Minneapolis contribution came at the conclusion of Morris Stein's report on the status of the Socialist Workers Party

and the need for the utmost sacrifice to get the anti-war message of socialism out to the greatest possible number of people during the 1952 election campaign. He also stressed the importance of the civil rights struggle in Michigan against the Trucks "Witch Hunt" Law and the need for funds to keep on top of this fight and to give it the widest publicity.

The St. Paul delegate took the mike to report about the work of this branch of the SWP and concluded with the announcement that the Minnesota delegation had voted unanimously to increase its pledge by \$500 "and this amount will be paid before we leave the Convention." He got a big hand from the convention.

At the next session Morris Stein again took the floor: "It seems as though many problems are being tackled here by the delegates in a spontaneous manner. The Minnesota delegates handed in that \$500 right after they made their announcement. And that started a chain reaction. Or at least the beginning, I hope, of a chain reaction.

"This morning the Buffalo delegates said they have been scouting around and it looks like another \$500 from them is a sure thing. This represents a great sacrifice for them as many of them have been out on the picket lines now for about two months."

This week, a total of \$858 brought the score up to \$6,860 through July 21. That's 38% of the new \$18,000 goal.

Connecticut, in first place with 78% of its \$125 pledge, sent in \$17 of which "Nick Lyons gave \$12 to help in the presidential election."

In addition to Connecticut, five other branches are on schedule in the campaign with 54% of their pledges or better: Minneapolis-St. Paul, Buffalo, Detroit, Cleveland and Chicago.

O. C., a delegate from St. Louis, brought \$25 to help put a socialist in the White House, pulling this branch out of the zero level way up to the 50% category.

San Francisco chalked up a \$90 gain and now has 25% of its \$900 pledge.

A \$25 check lifted Youngstown out of the zero column and up to 6% of their goal.

The Boston delegation delivered \$68, doubling the branch score.

Our friends in the South sent in \$20, stating: "We want to raise our pledge from \$140 to \$150. A \$10 increase to help clean out the war-profiteers."

A Socialist Workers supporter in Toledo contributed \$5 to help

Full Text of CBS-TV Speeches By National Nominees of SWP

"Injury to One Is Injury to All" Must Be Civil Rights Slogan -- Dobbs

Our country was founded on the great tradition of human liberty set forth in the Declaration of Independence. We, the people, were guaranteed protection from tyranny by the Bill of Rights.

These principles are today being destroyed by power-drunk politicians and military brass who are pushing us straight toward war on a world scale.

Americans once had the unrestricted right to think for themselves and freely speak their minds in the public forum. Now we have thought-control imposed upon us, by unconstitutional laws and presidential orders, by politicians who slander people under the cloak of Congressional immunity. Today speakers who oppose the war are banned from public halls and driven from the streets by the police.

There was a time when we could associate with anyone we pleased, regardless of their ideas, and be free from the snooping government stool pigeon. These days we are branded subversive if we associate with people holding unpopular ideas, and any stool pigeon's word will be taken against us.

In the past we could go to other countries whenever we pleased, be friendly with anyone we chose. This is no longer true. You can't get a passport if the State Department doesn't like the way you think. Association with opponents of capitalism abroad makes you an immediate target of the political police here at home.

People from other lands were once welcomed to our shores without discrimination. Today our government closes the door to immigrants who have the wrong political ideas or the wrong nationality.

Our tradition has been that a man's home is his castle. But this tradition no longer prevents the American Gestapo, commonly known as the FBI, from invading our privacy. They pry into our personal affairs to see if we are criticizing the war program. These political cops consider every criticism a plot to advocate overthrow of the government by force and violence.

The constitution guarantees that accused persons shall have the right to trial by jury, a lawyer to represent them, and the right to cross-examine their accusers.

Today the witch-hunters bring people before loyalty boards, legislative committees and other kangaroo hearings; they accuse them of political crimes — a practice that is common in totalitarian countries, but has no place in a democracy; and in the farce that passes for a judicial investigation, they violate every rule of trial procedure required by the constitution.

The accused is not told the nature of the alleged evidence against him. He seldom knows who his accusers are and is denied the right to cross-examine them. He is often denied even the right to have a lawyer.

Entire organizations have been convicted without any hearing whatever under the Federal subversive list and notorious laws like the Michigan Trucks Act.

FULL EQUALITY DEMANDED FOR THE NEGRO PEOPLE

NEW YORK, July 18 — The Socialist Workers Party at its nominating convention here today demanded full social, political and economic equality for the Negro people.

"The Republican and Democratic Parties are both White Supremacy parties," the resolution adopted by the delegates stated. "They have united to make second-class citizens of Negroes, Puerto Ricans and Mexicans."

The Socialist Workers Party stated in its resolution: "We

stand for the abolition of the poll-tax, for a strong anti-lynch law; we demand an FEPC law that empowers the government to enforce genuine equality; we demand the outlawing of restrictive covenants in housing and for the complete abolition of Jim Crow."

The statement further declared: "The Truman administration has done nothing to stop the victimization of Negroes by home burnings and bombings, legal lynchings and police brutality."

Presidential Candidates Pledged to Fight for Worker-Farmer Govt.

NEW YORK, July 20 — Farrell Dobbs, National Chairman of the Socialist Workers Party, was named as the party's candidate for President of the United States at its four-day 15th National Convention, which concluded its sessions here late this afternoon.

The convention also nominated Mrs. Myra Tanner Weiss, Los Angeles party organizer, as the SWP candidate for U.S. Vice-President.

A series of national television and radio broadcasts of their acceptance speeches and other talks by the candidates highlighted the convention events. Texts of the acceptance speeches are printed in adjacent columns.

The candidates both pledged a vigorous fighting campaign to bring the emancipating program of socialism to the American people, who are hounded by fear of war, insecurity and destruction of civil rights.

The two SWP banner-bearers called on the working people, racial minorities and all exploited layers of the population to join with the Socialist Workers Party in its militant struggle to break the grip of the capitalist political monopoly and to place a party of the American workers and farmers in office in Washington.

The convention delegates and visitors, who packed the Cornish Arms Hotel ball-room throughout the convention sessions, responded to the fighting appeals of their candidates with tremendous ovations. In the face of the terrible witch-hunt and repressions which have been growing in this country over the past years of capitalist war preparations, the convention gave a remarkable demonstration of high party morale, enthusiasm and revolutionary optimism.

CHALLENGE DEMOCRATS AND REPUBLICANS

The delegates drafted, discussed and adopted a platform that challenges all down the line the pro-war, anti-labor, Jim-Crow programs of the Democratic and Re-

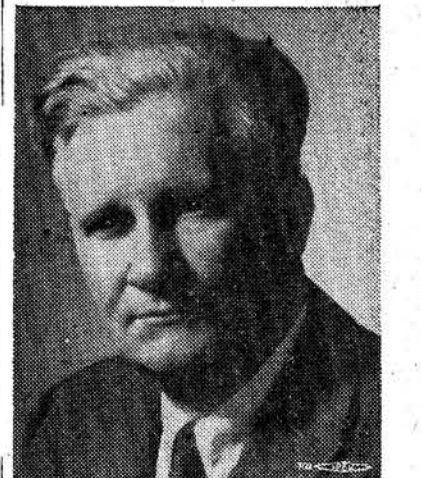
publican twin-parties of Big Business.

Plank Number One of the SWP platform pledges unyielding opposition to the war plot of U.S. imperialism. Big Business is seeking to avert an economic and social crisis of capitalism here at home and to put down working-class revolutions and colonial uprisings abroad with world-wide military conquest.

The platform demands that the Korean War be stopped now and that all U.S. troops be withdrawn at once. It calls for taking the war-making powers away from

Democrats Yield to Race-Haters

With all wings of the Democratic Party fully committed to an aggressive war policy, little attention was paid at the Democratic National Convention to international affairs. Instead, the politicians busied themselves with the Southern Bourbon wing of the party. The so-called New Dealers and Fair Dealers had promised to fight for a plank promising federal fair employment legislation with teeth in it; but, at the convention, the keynote was compromise.

Compromises were in the air on every side: compromise on the candidate, on the platform and on the "party regularity" pledge. Indeed compromise with the reactionary race-haters of the South was so much the vogue that it reminded one of the days before the Civil War when the Democratic Party was known as the party of slaveholders and "dough-faces," the latter being defined as "Northern men with Southern principles."

For its candidate, the Democratic Party appeared to be on the verge of choosing Adlai Stevenson, Illinois governor, who the N.Y. Times says, "has managed to retain the admiration of the Northern liberals without alienating the Southern conservatives."

On the issue of "party regularity," that is to say, a Dixiecrat revolt and the measures it would be met with, the convention again

worked out a compromise that is really a capitulation. The Fair Deal Humphrey-Lehman wing started out threatening that every delegation would have to swear to a "loyalty" pledge, binding it to work for the candidate nominated in the convention. By the time the compromises had been worked out, all delegations from states which have laws that can be interpreted to bar such pledges were exempted, and delegations that had been pledged in advance against such a course had also been exempted.

In the end, three Southern state delegations refused to take the pledge, but at this writing they remain in their convention seats and attempts are being made to work out a further "compromise" that would leave them there.

"LIBERALS" LOSE "FIGHT"

The civil rights plank of the Democratic platform is another such "compromise." The key conflict on this plank was over the words "enforceable" versus "effective." While this may seem an unimportant distinction, it symbolized the issue under dispute, and the rejection by the platform committee and later by the convention of the fight for "enforceable" legislation against racial discrimination has been universally taken to mean that the Democratic Party "liberals" lost their fight.

Of course, the platform is of

very little importance anyhow. They had a so-called "strong" civil rights plank in their 1948 platform, and what is more, had a candidate who said he favored that plank in no uncertain terms. However, after the election these campaign promises were filed in the waste basket. What can the Negro people and other minorities expect of a far worse platform and a "compromise" candidate?

SHABBY FORMULA

Stevenson, the probable candidate, has said on the issue of civil rights: "I feel very strongly that this is the first responsibility of the states themselves." This is the shabby formula that has been used to avoid any action on civil rights for three-quarters of a century, ever since the compromise of 1876 when the capitalists of the North turned the rule of the South back to the Southern Bourbons. No wonder Stevenson is called by the N.Y. Times "a man who is not likely to incite the Southerners to further riot."

The labor leaders, scurrying around the convention with their label pinned on their chests: "Support some capitalist politician at all costs," secured the adoption of a platform plank advocating repeal of the Taft-Hartley law. This is a repeat of the 1948 Democratic plank. However, Stevenson has said: "Some features of the law seem to me to advance the cause of good labor relations,"

and other features, in my opinion, do not. I think the Democratic platform should recommend modifications."

This raises the following question: If the Democrats, with a President who said he stood for "immediate repeal" failed to scratch the Taft-Hartley law in five years, and moreover used that law to break many strikes, what would they do with a President who only wants "modifications?"

BI-PARTISAN POLICY

In the field of foreign policy, the Democrats pledge to continue their course towards World War III. This war drive has also been endorsed by the Republican Party at its recent convention. This means that Wall Street can now lean back and feel satisfied with both parties. It has what it wants no matter which party takes office to administer the war drive.

Wall Street places first stress on foreign policy for two reasons: the war drive fills its needs abroad, and it determines the course of domestic policy as well. Any party which drives towards war will also have to destroy civil liberties, gag the people, put the race-haters in power, repress labor, cut living standards and abandon most of the social reforms won in the past. This will be the course of both war parties no matter what their platforms pledge.

Our Candidates -- Their Records

Farrell Dobbs -- Fighter for Labor

The force of a great idea and a cause bigger than self can transform a seemingly ordinary man, a worker, and lift him to a stature immeasurably higher than the stunted role assigned to him by capitalist society.

Such a cause is the socialist emancipation of labor. Such a man, transformed and lifted up by this cause, is Farrell Dobbs, our candidate for U.S. President.

He was born in Queen City, Missouri, in 1907.

From the age of six, he lived in Minneapolis, Minnesota, where he got his schooling. After graduation from high school, he got a job as a wire man for Western Electric. Through self-education he qualified as a planning engineer. He was on the way "up."

The crash of '29 ended all that. By 1933, Farrell was trying to beat off debt and insecurity and feed his wife and three children as a coal yard worker.

He joined the union of coal yard drivers and workers then being organized by labor fighters like Vincent R. Dunne, Grant Dunne and Carl Skoglund. Farrell was in the thick of the battles of the great truck drivers strikes of February, May and July 1934 which brought unionism to open-shop Minneapolis.

He was a member of the negotiations committee where he displayed his exceptional abilities -- cool judgment, attentiveness to details, uncompromising firmness, an analytical mind that cut through all the deceptions of the bosses and arbitrators.

He was elected repeatedly as secretary-treasurer of famous Truckdrivers Local 544 and served as an officer until 1939. In 1937, he was elected secretary of the newly-formed North Central District Drivers' Council out of which grew the Eleven State Area Committee, of which he was secretary. He was chief spokesman in negotiations that won a 12-state uniform contract for more than 250,000 over-the-road drivers. In 1939 he became a general organizer for the International Brotherhood of Teamsters.

In March 1934 he had joined the movement that later founded the Socialist Workers Party. In 1940, at the call of the party, he turned his back on a well-paid union post to begin full-time work as SWP National Labor Secretary.

When Local 544, in June 1941, broke from the bureaucratic stranglehold of Teamsters Czar D. J. Tobin, Farrell Dobbs was on hand to aid the fight of the rank and file. Tobin appealed to President Roosevelt, who responded by directing the Department of Justice to initiate the Minneapolis Labor Trial.

With 17 other Minneapolis CIO and SWP leaders, Dobbs was tried under the Smith "Cag" Act in 1941, convicted of the "crime" of advocating socialism and opposing imperialist war and sentenced to federal prison for sixteen months. He was imprisoned for his principles in 1944, returning to his duties as Militant editor in 1945.

In 1948, he was his party's choice for U.S. President in the SWP's first national election campaign. Since then he has been party organizer in Chicago.

Myra Weiss -- Champion of Oppressed

Myra Tanner Weiss, our candidate for Vice President of the United States, started out to become a chemist. Instead she became a full-time socialist fighter for the American working class and an outstanding woman champion of the rights of oppressed minorities.

"I was a chemistry major in college in 1935 when I became convinced that a second World War was in the making," she relates. "I figured if I continued with chemistry I might end up by making bombs. I decided it was better to spend my time helping to remove the causes of war."

That same year she joined the Workers Party, then the name of the present Socialist Workers Party, and has fought courageously for its program ever since.

She is a descendant of the earliest founders of this country. Her first ancestor in America arrived in 1632. Her forbears fought in the American Revolution -- on the side of the revolutionists. Later ones fought in the Civil War -- against the slaveholders. Still later ones broke trails across the plains and mountains to pioneer the West. She has kept faith with her revolutionary heritage.

Myra was born in 1917 in Salt Lake City, Utah. She completed her education at the University of Utah and the University of California, Los Angeles branch.

In 1936, she started work as a waitress for the Union Pacific

in Utah, getting \$1 a day, plus room and board, for an 18-hour day. She worked seven days a week. By putting up a scrap she got a 13-hour day every third day.

She helped to organize the terribly oppressed agricultural workers in southern California. She got a job as a migratory worker picking walnuts and lived in the migrant camps. She helped lead many strikes of the low-paid farm workers in the San Joaquin Valley and was made an honorary member of the Mexican Agricultural Workers Union (CUOM) because of her courageous defense of Mexican immigrant workers.

In 1940 she was a delegate to the Central Labor Union of San Pedro. In 1941 she helped negotiate wage increases for the Fish Cannery Workers Union, AFL, and served as committeeman.

Once, in Oakland while marching in an anti-fascist picket line, she was arrested for alleged assault and battery against five cops. She says the number was exaggerated. Mass labor protest secured her release.

Since 1942, she has been organizer of the SWP branch in Los Angeles. She ran for mayor in 1945 on an anti-war platform, and has run for Congress. Two years ago she won 18,000 votes for Board of Education member.

Myra won national recognition in 1946 for her exposure of the Pontana (Cal.) case, when a Negro family of four was burned to death after white supremacists threatened their home. She organized a West Coast protest and forced an official investigation, then wrote a pamphlet on the case, "Vigilante Terror in Pontana."

Reuther Boosts Harriman

24-HOUR HOLIDAY TO AID STEEL STRIKE PROPOSED

NEW YORK, July 17 — The Socialist Workers Party nominating convention today called for a 24-hour national holiday to show that American labor will not allow the steel corporations to have their way.

In a resolution giving full support to the steel strikers, the Socialist Workers Party delegates stated: "The steel workers' strike is every American worker's fight." The delegates condemned the stubborn attitude of the steel magnates, and protested government stalling of workers' demands.

"The arrogant and power-drunk steel corporations are refusing to grant a decent contract to the steel workers, and are insisting on exorbitant price hikes on steel tonnage to increase their already record-breaking profits," the resolution stated.

"The Socialist Workers Party calls upon the American labor movement to join together in a great demonstration of solidarity with the steel strikers to break the log-jam and force the corporations to sign a contract," the statement declared.

Viewers Praise Dobbs-Weiss TV Broadcasts

In the first mail after the national convention of the Socialist Workers Party, at which presidential candidate Farrell Dobbs and vice-presidential candidate Myra Tanner Weiss made radio and TV speeches on national hook-ups, 81 letters and postcards were received. Of these, 77 asked for copies of the speech and SWP literature; most expressed agreement and interest with the views expressed in the telecasts and broadcasts. There were four enclosures of money. Main Reports to SWP Convention

The political resolution before the Fifteenth National Convention of the Socialist Workers Party dealt with the class struggle in the U.S. within the framework of the critical economic, political and military position of the U.S. in the existing world setting.

Reporting on this situation, James P. Cannon, SWP National Secretary, summed up the position of U.S. imperialism as "a complex of irreconcilable conflicts on the international field and of unsolvable economic contradictions at home."

He then devoted himself to the "political heart" of the resolution, that is, all those issues that "do require examination and discussion, and unambiguous answers" by revolutionary socialists.

These fall under four headings: "1. — The present attitude of the American working class, in general, and its organized section in particular." A condition of "muffled class struggle" has existed in the post-war period.

"2. — 'The causes of labor conservatism,' arising primarily from the record 11-year boom of U.S. capitalism, and 'the premises for a new radicalization,' inherent in the economic consequences of the stepped-up arms program and the war drive, leading to the assaults, already started, on living and working conditions of the mass of the people.

"3. — The perspectives of a new radicalization; the forms it may be expected to take and the political tendencies which will contend for leadership."

"4. — The role and perspectives of the SWP in the whole process."

PERIOD OF ISOLATION
 Comrade Cannon pointed out that the party, along with the country as a whole, found itself "for the past six years" in a situation "radically different from the situation in the earlier period of the (rise of) the CIO, as well as the pre-CIO era. The post-war period marked for the SWP a period of 'organized isolation,'

because of the bureaucratization of the unions, the functioning of the labor officialdom as the agents of imperialism inside labor's ranks, the spread of the witch-hunt, etc.

The SWP suffered, as did every other grouping in the labor movement, from the offensive of reaction and the blows of isolation. But the SWP stood up better than did any other working class party or group.

Coming social convulsions will "radically change the situation," as past convulsions have done. And this will "once again open up great opportunities for the party."

The new social crisis, "with the profoundest revolutionary potentialities" is "in the making, and will not 'fail to arrive.' Its inexorable coming will 'pose the questions: 'Will we be ready for it? And prepared to make the most of it, when it comes?'"

The Fight for Civil Liberties

The struggle AGAINST the witch-hunt and FOR the preservation of civil rights came up as one of the pivotal issues before the SWP Convention. The report was by Farrell Dobbs, SWP Presidential candidate.

In broad outline, the party's standard-bearer sketched out the background of "the current assault on civil liberties in this country," its deep roots in the present war drive, and extending back to the drive toward World War II under Roosevelt.

That's where the witch-hunt has "its origin." "The witch-hunters got off to a strong start thanks to the signing of the Stalin-Hitler pact in 1939," Dobbs correctly said.

It was because of the Kremlin's support of Hitler that "popular opinion was scandalized in America and made it easy at the time to use the Stalinists, just as they are being used today, as the chief target for anti-democratic laws intended in the end to suppress the rights of all." The Hatch Act of 1939 "initiated the concept

ly, would have to wait the test of events. "But one thing can be said for sure. The final answer will be largely, and very probably decisively affected by the role and perspective we set for ourselves beforehand. That is the way the resolution puts this all-important question . . . That is not a mere ceremonial expression of future hopes. It is the calm assertion of Marxist truth.

"It is the realistic appraisal of our perspectives. If we stand firmly by our principles, and keep working; and make no serious mistakes of policy, our time and our great opportunity will come."

In conclusion Comrade Cannon said: "That faith in the future — based on the ideas of Marxism — is the source of our optimistic fighting morale, as we proceed to name our candidates for the presidential election of 1952 — another battle in the long campaign leading to the goal of Socialist America."

of the loyalty oath, so widely applied today." There came, too, the Smith "Gag" Law "father of all thought-control measures and among the most vicious of witch-hunt devices."

The war-time alliance with the Kremlin brought with it "a change in the form of these anti-democratic acts, repressive war-time laws and decrees," but no change in their substances. The would-be destroyers of civil rights benefited by the wartime support of "the Stalinists to every one of these steps which laid the foundation 'for what is happening today' in preparation for war against the anti-capitalist forces on the world arena," Dobbs said.

TRYING TO TURN BACK THE CLOCK
 To really understand the witch hunt, its scope and power, it must above all be borne in mind that "American capitalism is trying desperately to turn back the clock. Here at home as throughout the world." Otherwise, it cannot carry on its projected war.

Hence "the old blacklist of the open shop days has reappeared as a political subversive list." Hence the FBI "as political cops" duplicating the role of "the old-time coal and iron police." Hence the glorification of stooge-poles and hired informers as "national heroes." Hence a situation where not only are "the victims held guilty unless they can prove their innocence," but "even if they clear themselves they are marked suspicious" and will probably have to go through this ordeal again and again, and so on.

The entire government machinery is at the service of the witch-hunters — from Capitol Hill, where McCarthyism and McGarrism are rampant through the courts, particularly the Supreme

Court, which has upheld the Smith Act and thus "legalized thought control," down to the state and local legislatures, which are pouring out supplementary, and, in many cases, even more rabid anti-democratic laws.

THE TRUCKS ACT

As "the latest and worst example," Farrell Dobbs singled out the infamous TRUCKS ACT in Michigan. The SWP has been directly attacked under this act. "The Truck law fight," pointed out the reporter, "presents latest proof of our ability to win support among broad layers of la-

The Crisis of World Capitalism

Reporting on the world situation, George Clarke, Campaign Manager for Farrell Dobbs and Myra Tanner Weiss, singled out as the dominant factor "the unrelenting drive to war" by the capitalist rulers of U.S.A.

Imparting added impetus to the war drive are: "The pressure of overproduction," which has already found expression in the 16-month-old, world-wide consumer goods slump; there is "the weight (in U.S. economy) of the war economy" coupled with "the coming end of plant expansion."

To this must be added "the power of the military caste, whose growth remains unchecked in the face of popular anti-war sentiment."

This war drive takes place under conditions highly unfavorable to capitalism. The colonial revolution has extended and deepened. This confirms the forecasts made by the Third World Congress of the Fourth International last year.

Among the new developments Comrade Clarke listed the explosion in Egypt; the upsurge in Tunisia and Algeria; the rising clashes in South Africa and the unfolding Bolivian revolution.

Things are not going too well for capitalism in Europe, either. France, gripped by economic cri-

New Opportunities for SWP

"The greater the blows American capitalism suffers abroad, the more intense grows the pressure upon all the anti-capitalist elements at home," said Morris Stein in his organizational report to the 15th SWP Convention. "This is the reality we face in our struggle to build the revolutionary socialist party in the citadel of capitalist reaction."

Despite the difficulties of the last period, the basic framework of the party has remained largely intact. The over-all experience has demonstrated that the avenues of growth and recruitment, while reduced by the pressure of the witch-hunt, were by no means cut off.

bor, liberals and the population generally."

The SWP has the best and most consistent record in this country as the fighter for the civil rights of ALL. Comrade Dobbs called for the broadest possible extension of the struggle against the witch-hunt in general, and in particular against the Trucks Act and the recent McCarran immigration law under which "naturalized citizens" have been reduced, in effect, to the status of second class citizens whose citizenship may be revoked, on any informer's say so.

Since the 1950 Convention, the party had distinguished itself not only by its activities in the various election campaigns but by its foremost role in the struggle against the witch-hunt and the defense of the civil liberties of all its victims, including the Stalinists.

The party's record in this field is indeed an impressive one. There is the determined campaign and struggle waged around the case of James Kutchner, the legless veteran who was fired from his clerk's job in the Veterans Administration because he believed in socialism. There is the fight against the Kimball Act in the State of Washington. There is the unfolding campaign against the notorious Trucks Act in Michigan.

The reporter noted that paralleling the crisis of imperialism was the crisis of Stalinism. He cited the conflicts inside the satellite bureaucracies in Eastern Europe and between them and the Kremlin bureaucracy (the recent purges in Czechoslovakia and Romania).

"The power of U.S. capitalism can only be understood in relation to the world," concluded Clarke. The plunge into war will precipitate a world-wide social crisis, capitalism will be unable to survive. "The fortitude to resist the terrible ordeal which we shall face can come only from the consciousness that we are part of the swift moving stream of history, which despite distortions, is that of the revolutionary transformation of the world."

Among the letters we received in response to the TV broadcasts of Farrell Dobbs and Myra Tanner Weiss, was one from "an old Socialist of the earlier years of the century, a contemporary and personal friend of Gene Debs and other old war horses of the workers' struggles to whom the workers owe so much."

He was reminded of Eugene Victor Debs, outstanding Socialist leader who was jailed in the World War I period for opposing imperialist war and advocating socialism.

This was not the only Socialist of Debs' time who recognized the authentic voice of American socialism. We received letters from other old Socialist fighters hailing the speeches.

These seasoned warriors in the struggle for a better world than the present sorry mess were correct in their judgment. The Socialist Workers Party does stand in the fighting tradition of Debs.

Our roots go back in America to 1776, to the militant colonials around Sam Adams, Benjamin Franklin, Thomas Paine, Thomas Jefferson and that whole galaxy of patriots who dared to stand up against a government grown tyrannical and fight for a new government molded according to the democratic will of the American people.

Our heritage likewise includes the spirit of the Abolitionists, the American militants of a century ago gathered around Wendell Phillips, Frederick Douglass and John Brown who refused to condone the slave system, and did not rest, no matter what the vilification and persecution, until that foul and tyrannical threat to a free America was torn up root and branch.

Our ideas go back to the beginning of socialism in America, especially, to the heroic pioneers around Albert Parsons and August Spies who built the first real party of socialism in the teeth of savage reaction that demanded and took the lives of these leaders in the famous Haymarket labor case of 1886.

The Socialist Workers Party is completely American, but not narrowly American. Five Years of Civil War -- The Prelude in Korea

From the start of the Korean war and U.S. intervention, the spokesmen of the western powers have misrepresented the war's origin as an "unprovoked aggression" by North Korea against South Korea. They have vehemently and falsely denied that the war originated in an internal struggle between Korean classes and regimes.

For the imperialists to admit the existence of civil war would be to confess that their intervention violates their own United Nations charter which forbids the UN "to interfere in matters which are essentially within the domestic jurisdiction of any state."

The attempt to reduce, the ori-

gin and nature of the Korean War to the simple question of who fired the first shot or who provoked whom on June 25, 1950, is a fruitless endeavor. That is something we can never know. Because the first shot in the Korean conflict was not fired on June 25, 1950. It is lost in those FIVE YEARS of sharp, bloody civil and class war that preceded and led up to the events of June 25, 1950.

Bitter class conflict among the Koreans has been recognized and reported since the end of the second World War by the ablest journalists and authorities on the Far East. From the first, they have described the struggle that has been waged between the poor and the rich, the workers and peasants on the one side and the capitalists and land-owners on the other.

RECOGNIZE NEW CHINA, SAYS SWP TO U.S. GOV'T

July 20 — The Socialist Workers Party, at its nominating convention in New York, in a resolution unanimously adopted by the delegates, today demanded that the United States Government immediately recognize the New Government of China.

"The Socialist Workers Party hails the Chinese revolution," the resolution stated, "giving unqualified support to the Chinese masses in their struggle against im-

perialist domination and for their own independence."

The delegates also called for the withdrawal of all American troops from Asia, an end to the blockade of China, and the vacating of U.S. military bases in Japan, Formosa and Korea.

The resolution demanded an end to "interference in the internal affairs of China," and that "friendly relations and normal commerce be resumed between the Chinese and American people."

the Stalin police regime in Russia. But I think that is the affair of the Soviet people. And I think they will overthrow this hated dictatorship if they are left in peace.

The politicians of the Democratic and Republican parties — all of them — tell us over and over again that war is being thrust upon us by others who want to attack us.

They say we must answer this alleged threat by a tremendous show of overwhelming military force.

Build up armies and navies and air forces of millions.

Turn the labor and productive means of the country to making the biggest and most destructive weapons ever devised by the mind of man.

That's what they say is the cause for war and how we can stop it.

It's a lie from beginning to end.

Ask yourself: Is the Russian army within 200 miles of the American border? Or is an American force of half a million men within 200 miles of the Manchurian and Siberian borders?

Do the Russians or Chinese have troops and air bases in 55 foreign countries scattered around the globe? Or does the United States?

Are the air forces and armies of any other nation or combination of nations encircling us? Or is an iron ring being forged completely around the borders of the Soviet Union?

A look at the world map tells us the truth.

No one is threatening us.

We are doing all the threatening.

The war danger is not from without.

The war danger is from within.

No doubt you've heard the expression about the first World War and the second World War and now about the Korean War that "this is a rich man's war and a poor man's fight!"

The late President Woodrow Wilson — who led us into the war in 1917 — confessed afterward in a speech in St. Louis that it was not a war to "make the world safe for democracy."

He said it was a "commercial war."

It was a war fought for business reasons.

And — in a manner of speaking — every war that we have been thrust into or that we have been thrust into under the system of capitalism and private monopolies will be a war for business.

It will be a war for profits.

It will be a war to stave off a depression.

It will be a war to open up new fields for profitable investment.

It will be a war to prevent the peoples all over the world, who are now fighting to be free of foreign exploitation, from gaining their independence.

It will be a war to keep this profit system going at the expense of the people who do the useful, honest work of our society.

It will not be our war.

It will be the war of those who

stand to profit from it — the big bankers, the industrialists, the grafting government officials and military brass who give out the war contracts.

But they don't and won't do the sacrificing and the fighting and the dying.

That will be done by the common people — the ones who have nothing to gain and everything to lose by war — the ones who have been denied even the chance to voice their opposition to it.

They didn't ask you or me what we thought about it when they dragged us into the Korean "police action" that's been running for over two years now.

The Trumans and the Eisenhowers and the Tafts — they all talk about fighting for democracy — but they are against letting the people decide for themselves whether or not we should take the awful plunge into war.

Everybody knows that Truman did not even consult Congress when he plunged America into the civil war in Korea.

We woke up one morning to find that we were committed to war in Korea.

While we were asleep, in the middle of the night, we were involved in this murderous enterprise which has already cost us over 120,000 admitted battle casualties and reduced the whole of Korea to rubble.

Everything they have told us about this war we never wanted and never approved, is a lie.

Take the matter of casualties.

I just spoke of 120,000 battle casualties.

But how about the thousands of frost-bite cases?

Aren't they casualties of the war?

Or take the claim that we went all the way over into Korea to defend democracy there.

Now we are told that this government of Syngman Rhee in South Korea is nothing but a one-man dictatorship.

I could go on citing fact after fact after fact that would prove conclusively that our intervention in Korea has been bolstered by a mass of lies.

The war-makers have lied to us because we did not have the power to wrest the truth from them.

We could not halt their war scheme in advance.

We had no say-so.

We women take pride in the fact that we won the right to vote in 1919 after a century of struggle for our civil rights.

Yet on this most crucial question — this question of life and death — this question of war or peace — we have been gagged.

Not only do we have no vote on the most vital question affecting us as wives and mothers — we get a witch-hunt intended to intimidate and silence us altogether.

What are they afraid of?

Why don't they want the people to decide this question on which the fate of all mankind rests?

If the people had the power to decide, they would ask questions first, they would investigate, they would demand the facts.

the other. The American authorities who maintained a four-year military occupation of South Korea consciously aided the rich.

SWING TOWARD RIGHT

Gordon Walker, Far Eastern correspondent of the *Christian Science Monitor*, wrote from Seoul on Nov. 12, 1945, that "dominant under American Military Gov't tutelage . . . is a swing toward the conservative right wing, with big landowners and financial interests forming a solid political power bloc . . . dominated by Korea's four big families — Kim, Yunchi, Pak and Han — which compare roughly with Japan's Zaibatsu of eight families in exercising hegemony over the country's land and industry."

These four families, Walker explained, are the nucleus of Korea's Yangban "or century-old upper class (which) suffered very little under Japanese occupation" and were bent upon recouping control of the 80 per cent of Korea's land and property which the Japanese had taken over.

These few rich families, wrote Walker, "are working strenuously to prevent the growth of anything which smacks of communism, socialism or even economic liberalism. Some of its leading members now constitute the bulk of the advisory council for A.M.G."

LIBERALS AND PATRIOTS

The chief political opponent of the capitalist-landlord group was the group which called itself the "People's Republic" and "is composed of young liberals, including

profiteering war corporations wouldn't be able to pull a Korea on us any more. That's why they don't want to let us vote on war or peace.

"Where 8 Million Enjoy Benefits --"

"About 3 a.m. I was awakened by a struggle on Manhattan Ave. and 104th St., a 'Shaken Citizen' writes in today's N. Y. Post (July 23), 'I saw two men brutally kicking and beating a man lying in the street. I was about to call the police when I saw that the attackers were policemen. They never accused the man of anything and finally left. The dazed victim hailed a cab driver who helped him away. I'm sure the Negro cab driver could be found to corroborate this story.'"

After this, I turned to the N. Y. Compass and read that Mrs. Julia Lifshultz and her seven children were evicted Monday from their home at 62 Fourth Ave., Brooklyn. They spent the day on the streets, huddled in a doorway during the driving rain. After a flood of phone calls from indignant neighbors, city officials carted the furniture to a warehouse and moved the family into a municipal flophouse, where they are presently residing. They were dispossessed on court order because their landlord is planning on "renovating" their six-room, \$57.50-a-month apartment into two \$67-a-month apartments."

After reading the above items I decided to listen to some music before turning in. I caught our Municipal station WNYC just as they were signing off with their nightly, "This is New York, the city of opportunity, where eight million people live in peace and harmony, and enjoy the benefits of democracy."

The late George M. McCune, an outstanding American authority on Korea, described the "Right versus Left struggle" as the "dominating feature of South Korean politics," in the Oct. 15, 1947 *Foreign Policy Reports* of the Foreign Policy Association.

The Right was in a "more powerful position" because of its "wealth, political control and demagogic appeal" while the Left "had a strong popular following because of its revolutionary agrarian and industrial platform. The rank and file following of the Leftists was drawn chiefly from the farmer class which was dismayed by the lack of a land-distribution plan and bitterly opposed the rice-collection program. Factory workers and miners were discontented because the management of industry had been turned over to alleged Korean 'profiteers' instead of the factory workers."

McCune then wrote that it was "the considered opinion of many observers that . . . the Koreans are being driven toward communism as a consequence of the non-democratic and often reactionary activities of military Gov't. and its Korean officials."

GREAT STRIKE STRUGGLES

There were repeated reports of great strike struggles and labor demonstrations in South Korea from the first days of the U.S. military occupation. The *Militant* of May 18, 1946, contains an appeal from the Korean Federation of Trade Unions to the American CIO to help the hundreds of thousands of Korean unionists rid

themselves of a regime conducting an anti-labor campaign under decrees "worse than the cruel laws of Japanese imperialism."

Conditions in South Korea under the AMG and its Korean collaborators, like Syngman Rhee, were graphically described by our own eye-witness correspondent, Bill Morgan, in the March 15, 1947, *Militant*. He tells of the hundreds of thousands of dispossessed workers and peasants crowded into terrible slums "plagued by disease and hunger" in Pusan. "Thousands of Koreans live in cardboard shacks, in caves dug into hillsides, in abandoned warehouses, in doorways, in the narrow spaces between houses . . . Every morning many dead people are found — frozen, starved or shot by the police. Gangs of children roam the city and search for food or work."

POLICE BRUTALITY
The brutalities of the police beggared description. "We had never seen such cold-blooded

brutality. We saw them beating workers — men and women and children — every day." These police had learned their "trade" under the Japanese imperialists and were eager to practice it under an even richer, more powerful master, U.S. imperialism. Thus, Morgan wrote, "hatred for American imperialism is everywhere."

And with it, "Evidence of a powerful class struggle is everywhere. The American brass hats and the Korean police have not been able to prevent strikes. Trade union leaders are arrested and tortured, but the struggle goes on day and night. Many workers are armed and fight to maintain the independence of their towns and villages. Free elections are banned because the vote for radical candidates would wipe out the present puppet government set up by Lt. Gen. Hodge."

Here is the rumbling thunder presaging the storm of civil war.

Our legal tradition provides that the accused be considered innocent until proved guilty. The witch-hunters stand this on its head. They hold intended victims guilty until proved innocent. Even then they are made to bear the mark of suspicion that is so well-known to every ex-convict.

This attack on freedom of thought and expression in this country has gone so far that the conservative leaders of the CIO steel union warned against it at the union's recent convention.

In a resolution unanimously adopted the Steelworkers convention spoke to the people of America in the following words:

"The danger from domestic communist activities has been dwarfed in recent months by the subversive activities of reactionary forces who attempt . . . to whip up hysterical fear and suspicion of all liberal, forward-looking ideas and persons."

Perhaps some of you who are listening may think that the steel workers are unduly alarmed. Perhaps you believe that I have exaggerated in my description of the mounting threat to our civil liberties. You may feel this way because the witch hunt hasn't yet hit you directly; at least not in a manner that has made you aware of it. Let's pose a few questions for you to think about. Maybe your answers will show that you've already been affected more than you realize.

Do you feel free to state publicly your actual opinion about the war in Korea? Or are you careful to express your real thoughts about it only to your friends?

Do you feel free to complain about the big tax bite that is taken out of your wages to finance the war program? Or do you find it safer to merely complain that taxes are too high in general?

Do you feel free to speak your real thoughts about a foreign policy that is putting millions of our youth in uniform? Or do you find it safer merely to express regret that our young men must be taken from their homes to risk death on foreign battlefields?

When you think about it for awhile, you begin to realize that it's not as easy as it used to be to express your real thoughts publicly, especially if you don't like the war.

The Republican and Democratic co-authors of the present war policy know it isn't popular. They know the people will become even more dissatisfied as the war is extended against other countries. They intend to curb this dissatisfaction by making it unsafe to criticize the war policy.

They begin by attacking peo-

ple who hold the least popular ideas; then they go deeper into the population, step by step, figuring that if a million or two are victimized for talking, the rest of the people will be afraid to open their mouths. Concentration camps are already being built for this purpose.

The warmakers and their political police fear the real voice of the people because they are acting against the interests of the people. Like all tyrants who act against the public interest they must first gag those whom they would betray.

As Al Capp, creator of *L'il Abner*, put it we are even suffering gradual loss of our freedom to laugh at each other. Mr. Capp merely tries in his cartoon strip to give us a good chuckle. Yet he told in a recent *Life* magazine article of receiving indignant letters accusing him of kidding Big Business, of creating pacifism and non-resistance to communism.

This witch hunt can be fought only by the principle that an injury to one is an injury to all. If we stand aside, while somebody else's rights are being suppressed, we have helped bring the thought-control police a step closer to our own door.

The Stalinists, who have themselves been heavily victimized, violate this principle by refusing to defend the rights of their political opponents. Their conduct helps the reactionary clique that is trying to push our country toward police-state rule.

Union officials and Negro leaders usually make the same fundamental error by refusing to defend the democratic rights of the Stalinists. This policy helps pave the way for use of the subversive list and anti-democratic laws against unions and Negro organizations.

The Socialist Workers Party — which has honored me with the nomination as its presidential candidate has an unblemished record of principled conduct in defense of democratic rights for all.

We are firmly opposed to the policies of the Stalinized Communist Party. Yet we defend all Stalinist victims of the witch hunt.

We sharply disagree with many policies of the union officials and Negro leaders. Yet we defend them when they are attacked by the thought-control police.

We stand squarely on the principle that if defense of civil liberties means anything, it means we must defend the rights of those with whom we disagree. It means we must oppose all laws and presidential orders that impair freedom of thought and expression.

To completely stop this assault on democratic rights, we must

strike at the source. We will find the source in the domination of government by Republicans and Democrats. So long as these political agents of the wealthy class remain in control, the witch hunt will be with us.

The attack on democratic rights can be completely stopped only by removing all Republicans and Democrats from office and replacing them with a Workers and Farmers government. Such a government, genuinely representative of the working people, would act to promote peace, instead of war.

It would encourage free expression of public opinion and be guided by it, instead of trying to regiment people's minds through thought-control.

The establishment of a Workers and Farmers government is the main plank in the platform of the Socialist Workers Party. We ask you to support us in working to attain this goal.
