TENN. PRISONS HELL HOLES REPORT SHOWS

NASHVILLE, Tenn. — In a report released March 18th the Tennessee Legislature's Penal Committee is forced to admit that conditions in the Brushy Mountain Prison and the main Penitentiary at Nashville are worse than in the Siberian prisons under the Czar before the revolution.

The report tells of women prisoners at the Nashville Pen being handcuffed and hung from pipes on the wall for 19 to 22 hours because they were unable to put out enough work in the hosiery mill to satisfy the slave driving warden. Both men and women prisoners are stripped to the walls and lashed into prostration by the whipping boss for the slightest fraction of rules the committee found.

Prison A Fire Trap

In the Brushy Mountain branch of the main prison the committee reports 975 men crowded into a frame building to hold less than a third this number. Over 200 of the prisoners have venereal diseases, contracted in most cases since they entered the prison as diseased prisoners are not segregated. At the present 128 are down with pneumonia and 64 without medical attention and left in their beds to die as the warden claims he has no adequate hospital to house and care for them.

The Brushy Mountain prison is a regular fire trap and a fire here would result in "a tragedy at Brushy Mountain the like of which has never been seen in an American prison. The wiring on this old structure is of the most dangerous character and is liable at any time to cause a fire." Under present conditions in case of fire hundreds of men would die like rats in a trap without a chance for their lives.

Despite these horrible conditions which it is forced to admit because unable to conceal them, the committee does its best to whitewash the prison administration, stating that "the conditions which exist at Brushy Mountain are in no sense the fault of the commissioner of institutions nor of Capt. W. H. Nelson, warden."

115 Jailed in Orleans Strike; Mass Picketing Starts On Call M.W.I.U.

New Orleans, La. — Harold Hynes, National Secretary of the Marine Workers' Industrial Union, and H. Harvey, National Organizer for the Union, were sentenced to ten days in jail for violation of the Federal Injunction against mass picketing Saturday. The organizers were charged with distributing leaflets signed by the union calling on the 5,000 longshoremen to mass picket on the docks and keep out the scabs as the only way to win the strike.

NEW ORLEANS, La. — 35 striking longshoremen are held here charged with violation of the Federal injunction which prohibits strikers from coming near the docks where scabs are working to break the strike. Trial of the 35 strikers is set for Thursday. The charges against the 35 strikers, most of whom are Negroes, came as a result of a mass picketing demonstration of several hundred strikers on the docks last Wednesday. At that time 115 were arrested when the police attacked the strikers with clubs and with machine guns set up along

the docks ready to shoot down the strikers.

The strikers are becoming desperate and armed clashes between strikers and scabs take place daily. The longshoremen are beginning to see the sell-out their misleaders of the I. L. A. and the A. F. of L. are preparing for them. They are beginning to realize that the present policy of the leadership which forbids mass picketing and any fighting attempt to keep scabs off the docks, is losing their strike and must be changed to the militant policy of mass picketing despite the injunction proposed to the strikers by the Marine Workers Industrial Union.

The Trade Union Unity League and the Marine Workers Industrial Union have sent additional organizers to the New Orleans area in order to do more work in connection with the strike. The correct policy of the M.W.I.U. is to send more and more strikers to its program and they are putting the strike policy of the M.W.I.U. into effect in spite of the opposition of the misleaders.

"NO NIGGERS" SAYS A.F.L.

NEW YORK CITY — Declaring that "We don't take niggers into our union," a business agent for the Sheet Metal Workers Union of the American Federation of Labor, fired Maurice Barcourt, a colored metal worker, off the new Waldorf-Astoria building job.

Barcourt was approached on the job by the A. F. of L. union business agent who asked to see his union card. He showed him a card in the Metal Workers Industrial League, one of the revolutionary unions affiliated to the Trade Union Unity League, which fights against all forms of discrimination against Negroes. When Barcourt was told by the business agent that this card was no good on the job he offered to join the A. F. of L. union in order to hold his job. He was contemptuously told that the A. F. of L. Union takes no "niggers" as members.

One Killed By Overseer

MARION, Ark. — Mose Miller, Negro cropper died in the County jail here March 21st as a result of wounds received in a gun battle with L. H. Glover, manager of a large plantation near here on which he worked.

Glover attacked the cropper with a gun because he protested against attempts to cheat him at the plantation store. Miller defended himself from the brutal attack and killed Glover, only to die later from wounds he received in the fight.

Judge and Jack Miller, sons of the cropper, are held in jail at Wynnes, Ark. They had nothing to do with the fight they will probably be charged with murder and sent to their deaths as a warning to other croppers not to resist the brutal rule of the white master class.

WORKERS VOTE RED DESPITE BOSSES TRICKS

CHATTANOOGA, Tenn. — Mack Coats, Communist candidate for Judge in the city elections, received 128 votes according to figures given out by the Board of Elections. Leftist candidate for Mayor is credited with 90 votes and Cassidy, running for City Commissioner, with 118.

Vote Stealing Probable

Unquestionably many votes were stolen from the Communist candidate. The whole course of the campaign which saw the arrests of three leading organizers and the placing of prohibitive bills on them to insure that they remained in jail until after elections, the failure to let the Chattanooga Times or the News to print the names of the Communist candidates on the sample ballots appearing in their papers (this is most important as the party designation appears on the ballot) and the workers must remember the names of the candidates they voted for, the refusal to allow the Communist candidates to speak at any mass meetings where all other candidates were invited to speak, and the Communist rally on the day of the elections and the arrest of one of the candidates, Comrade Coats, who was held in jail with 200 dollars until after the election.

NTWU Nat. Council To Meet

PROVIDENCE, R. I. — The National Council of the National Textile Workers Union will convene here at Union Hall for a two-day session starting April 4th.

The call for the meeting of the Council, signed by Pat Devine, Secretary of the union, calls on all districts to elect delegates and to turn the Council meeting into a "small national convention."

The call points out that the recent great strikes led by victory by the N. T. W. in Lawrence and Maynard have again fired the textile workers of the whole industry with the will to struggle against the present unbearable conditions. Over 2,000 workers have joined the union in the last few weeks as a result of these struggles, the call states, and the union now has a firm mass base which will enable it to develop the work of organization of the coming strikes more rapidly than before.

Three delegates are to be elected from the Southern District of the N. T. W. to attend the National Council meeting. These delegates will be elected during the next week from mill committees of the union and from general membership meetings in the various Southern mill centers where the N. T. W. has locals.

Cropper Murdered

INDIANOLA, Miss. — George Span, Negro cropper, was shot down by police in cold blood here today. The police gave the usual excuse for such murders, charging that Span resisted arrest.

Span had Wednesday shot and wounded Charles O'Neil, his white landlord when O'Neil attacked him following the Negro cropper's protest against the landlord's attempt to cheat him out of his crop.

Mob Lynchings Miss. Negro

INVERNESS, Miss. — Steve Wiley, Negro farm worker, was lynched by a mob of white business men here early Sunday. The usual lying charge against Wiley was that he "attempted to attack a white woman."

Police officials are clearly implicated in the affair as they covered up all reports of the lynching until Tuesday, evidently to give time to the lynchers to prepare an alibi. No arrests have been made and probably none will be.

Chattanooga Trial Set March 31

CHATTANOOGA, Tenn. — The trial of Mary Dalton, Harry Gordon and Elizabeth Lawson, originally set for March 18th, has been continued until March 31st. The postponement was obtained due to the absence from town on the 18th of the defense attorney, G. W. Chamlee, Sr., employed by the International Labor Defense to defend the three leaders of the Chattanooga workers.

The three were arrested when police broke up a demonstration of 3,000 unemployed workers on Feb. 10th. The workers had gathered at Main and Market streets to elect a committee to visit Mayor Bass to place the demands for jobs for immediate cash relief before the city government. Tens of police and special deputies charged the demonstration with drawn guns, arresting 12. All except Dalton, Gordon and Lawson were later released.

In addition to the usual frame up charges of vagrancy and inciting to

riot placed against the three organizers, Dalton and Gordon are also charged with living together while unmarried. That this charge is a plain and simple attempt of the police to prejudice the jury against the workers on trial, and to make retaliating them to long terms in prison easier, is proven by the fact that these comrades were married in 1929 in New York City. The labor-hating police of Chattanooga are ready to stoop to any means to frame up the militant leaders of the working class.

The International Labor Defense, which is conducting the defense of the organizers, calls on the workers of Chattanooga, white and colored, to join the courtroom of Judge Lusk in the County Courthouse when the case comes up for trial, to show the boss-controlled city government they arrests and persecutions can never smash the struggle of the hungry masses for work or Unemployment Insurance.

WHITE RULERS DENY NEGROES SCHOOLING IN BLACK BELT

WASHINGTON, D. C.—One out of every 25 enrolling in the first grade of Alabama public schools reaches the eighth grade, according to figures given by the United States office of education.

22,152 Negro children were enrolled in the first grade of Alabama schools in the school year of 1927-28. The same year 4,387 Negro children were enrolled in the eighth grade. While there were over 22 thousand first grade pupils in the state, only 2,492 in the second grade. In other words out of those Negro children who are fortunate enough to get any schooling, close to half those who start school are forced to quit before they reach the second grade. The number in the higher grades grows progressively smaller until the eighth grade when only 2,743 pupils are reached.

The ratio for the rest of the South is about the same and in Alabama the South is a wide one of 1,212,000 Negro children in school and the average attendance at school is only 1,686,144 in Alabama alone. This is a sad state of affairs for the Southern Negroes get any school training at all.

Ruling Class Keeps Semi Slaves In Ignorance

That depriving Negro children of any education is a crime under the law which ruling class is graphically shown by conditions in the Alabama Black Belt. In Gadsden there is a school for white children with two well trained instructors in charge of 25 pupils. The Negro school in the same town has about 70 pupils, all of whom are taught by one Negro girl. The school term for the white children is 9 months while for the Negro children it is 3 months.

The big estate owners of the Black Belt are determined that their semi-slaves, the Negro croppers on the plantations, shall have no education which would enable them to conduct a better fight against the existing slave conditions.

The ruling bank about the present inferiority of the Negroes which is fed to the white workers in the South to divide them from the Negro workers, has its only basis of fact in conditions such as these whereby the Negroes are denied any opportunity to learn, read and write.

Lying Statements In Chattanooga Times

The lights in which the boss-controlled city machine of Chattanooga, Tenn., press and radio station, went to prevent the workers of Chattanooga from voting Communist can be shown by a few facts. Following this whole campaign of terror a reporter from the Chattanooga Times approached Comrade Coads in his cell. The City had on election night and asked him for a statement on the campaign. Coads issued a statement declaring that the smashing of the election rally at which he was arrested and the killing of a total of five Communist leaders just before the election, indicated that the bosses were on the run and afraid of the large Communist vote which would result from the elections the next day. Coads also stated that despite arrests and persecutions aimed at outlawing the organizations of the workers the Communist Party would intensify its activity following the elections and would win new thousands of Chattanooga workers to its support. After promising to print this statement the Times reporter himself wrote an entirely new statement which was printed as coming from Comrade Coads in which Coads is quoted as stating that if Judge Fleming did not send him to the chain gang he would renounce the "doc-

Murder Five As Prisoners Demand Food

JOILET, Ill.—Five unarmed prisoners, murdered, shot down by brutal guards in cold blood. This is the record of the State Pen here in the last few weeks.

The first murders came when prison guards ambushed and deliberately killed with machine guns two men who were trying to escape. Of course the guards knew of the escape plan and would have stopped it without bloodshed before it started, but they preferred to lie in wait and murder 2 prisoners.

The third death came when a prisoner died from the effects of torture after having been left for hours suspended by handcuffs from a peg on the wall in the punishment cell.

The prisoners revolted against this inhuman regime of murder and cruelty and in the resulting "riot" two more prisoners were mowed down by machine guns.

As this is written the prisoners in the two state prisons here are locked in their cells on a diet of bread and water. Cries of the men demanding food ring thruout the prison and further revolts may break out at any time.

GERMAN RED LEADER KILLED

HAMBURG, Germany.—Ernst Henning, Communist member of the Hamburg City Legislature, was murdered by three fascists, March 15th, after returning home from a political meeting in an auto bus.

The murderers, members of the country National Socialist Party (Fascists), fired six shots into Comrade Henning's body before he fell and then as he lay dead fired nine more shots into his body. Three of the hot shots were wild and wounded a woman and a child, also passengers on the bus.

This latest outrage follows a whole series of murders of leading Communist fighters by the Fascist murder gangs which are supported and maintained by some of the biggest German capitalists. Hundreds of memorial meetings in honor of Comrade Henning have been held thruout the whole country, at which scores of thousands of German workers have pledged themselves to intensify the fight against the boss class terror, under the leadership of the German Communist Party.

The Communist members of the German Reichstag have demanded that the workers defense organizations, the Red Front Fighters League, which the government has declared illegal, be allowed to function openly to protect the workers and their meetings from the Fascist mob.

The government on the contrary is doing all possible to protect the murderers and has banned all Communist papers in Hamburg and has prohibited all Communist meetings and demonstrations in an attempt to prevent the mobilization of the revolutionary workers for the defense of their Party.

German CP Gains New Members

BERLIN, Germany.—Latest figures show that the German Communist Party has recruited 84,000 new members in the past few months. Following the tremendous success of the Party in the Reichstag (roughly corresponding to the United States Congress) elections, the Central Committee of the Party gave the districts the task of doubling their membership in six months. It now seems certain that the quota will be reached. In the last national elections over four and a half million German workers voted for Communist candidates.

CODER, HURST BACK IN DALLAS

DALLAS, Texas.—Coder and Hurst, leaders of the Dallas boycott who were beaten and forced to a gang of blackened boys, are returning to testify before the grand jury supposed to be investigating the cowardly attack.

The kind of "investigation" it will be shown by the attitude of the Mayor, who has declared that the Communist demonstration held on the return of Coder and Hurst will be broken up by the police. There will be no more demonstrations in Dallas. Police are being mobilized and equipped with tear gas bombs and water guns to smash any attempt of the workers to protest the present terror regime. Despite the police terror the workers of Dallas will continue the struggle for work or bread.

Soviet Exports Up 14% Last Year When All Others Fail

WASHINGTON, D. C.—Figures released by the commerce department last week show that exports from the Soviet Union jumped up 14 per cent to a total of \$501,000,000 last year. This tremendous gain in exports in a period when, due to the economic crisis, the exports of all capitalist countries without exception fell off badly, shows clearly the great advantages of socialist planned production over the hit or miss methods of capitalism. The Soviet Union is the one country in the world which has escaped the effects of the world crisis and where there is literally no unemployment.

Wheat exports in particular showed a phenomenal rise last year, 34,149,984 bushels were exported in 1930. In 1929 exactly thirty-six bushels were exported. The great increase in the wheat crop which made these figures possible came largely as a result of the reorganization of Russian agriculture on a socialist basis and the development of huge collective farms. The position of the Russian farmer as one of the great collectives is in striking contrast to that of the American farmer, millions of whom face starvation this year, because under capitalism the workers are paid such low wages they cannot buy the cotton and wheat the farmers produced.

Convict Labor Here

At a time when hundreds of thousands of Tennessee workers are faced with starvation because they cannot find jobs the committee reports that the main prison turned in a profit of \$100,000 to the state last year from the sale of hosiery and other products of prison labor. At the same time the Brushy Mountain mines, manned by prisoners under the lash of brutal guards, is producing coal widely sold thruout the state which results in hundreds more Tennessee miners being thrown out of their jobs. In the mines and prison shops the convicts are driven at top speed for 12 and 14 hours a day and if unable to carry out the big tasks assigned them they are tortured and whipped. And in the face of this the government has the nerve to talk of "convict labor" in the Soviet Union!

It is to these hell-holes that the state is making every effort to send Harry Gordon, Mary Dalton and Elizabeth Lawson for long terms.

7th Worker Dies In Chatta. Flop House

Jordan Douglas, unemployed Negro worker, died Wednesday night in the City flophouse of Chattanooga. Coughing and groaning for two nights on the concrete floor which serves as a bed for three hundred white and Negro workers, no one paid any attention to him. The "charitable guardian" probably saying that this just makes one "nigger" less.

Douglas is the seventh unemployed worker to die in this flop house provided by the "sweet, considerate bosses" and City Council of Chattanooga. The other six were two white and four Negro. The local yellow sheet, the Chattanooga Times, was even forced to admit that Douglas died of lack of clothes, wearing only a pair of old shoes, trousers, coat and a hat.

Textile Worker Docked For Fake Jobless Relief

GREENVILLE, S. C.—The Westside Mill here, which boasts of being the "largest cotton mill square on roof in the world," just pulled a woolly head to heel.

For 7 weeks they took 25 and 30 cents from each workers pay envelope and with this money claimed they would buy groceries for the unemployed. No workers are on that committee handling the money or buying the groceries and distributing them. No one knows how much of the money "deducted" (it amounts to about 10) from the workers was granted to the committee of the mill management.

The workers who are forced to contribute 25 to 50 cents are paid \$4.50 a week. Their own families are without enough to eat but out of all starvation wages they give to the unemployed while the bosses who take the money and should be giving it, pass to part with a red cent. It is to put a stop to this and thru organized fight force the bosses to cross with Unemployment Insurance for every worker out of job with 75 cents and not the workers footing the bill. Houston Editor Steals \$5 From Young Worker

We are working 50 hours 30 minutes per week for the great sum of \$11. to \$16 per week yet they want us to work still another half hour each day.

Starting time is 6:30 and we are supposed to get an hour for dinner and stop off at 5:30 P. M. but they start the work about ten minutes to six in the morning.

They cut wages here a few weeks ago. They said they were going to cut down from 10 percent to 15 percent but they cut nearly 25 percent than 10 percent.

And on top of this the bosses come around and false tell about production and seconds. If you can't get 95% production and less than 2% seconds they take your bonus from you.

There is only one remedy for this oppression. Organize and fight as one. A Textile Worker.

Mill Boss Fools, Cheats, Evicts, Pregnant Mother

By A Worker Correspondent... I want to tell you something about how the mill bosses treat us poor workers here in Charlotte.

For more than a year now I have been working in the Calvine Mill when they would let me work.

Last fall we were cut down to three days work week. That is all the work we women could get. Our husbands couldn't get anything to do.

And we women only make three and four dollars for the three days. They would let us pay some rent and live on.

A week before Christmas the overseer came to me and said he was going to do me a favor. He asked if I was going to have a baby.

He would let me work a whole week instead of three days as I had 15 work. I was glad to do this. But I knew I would soon be confined.

But when I went to get the pay, what do you think they wouldn't pay me a cent. They said they would hold this for future house rent to take care of the time I was confined.

I had money enough coming to me to pay the rent until the second week in May. But now I have been served with an eviction notice and told to get out today.

My baby will be born in a few days and here I am being sent out on the street by the Calvine mill bosses.

Now what are we workers to do under such circumstances. I don't see anything for us to do but to organize. We workers must not move just because the boss tells us to.

We can live out doors and the boss sure will pay us their rent or no rent when even he wants to make us fight back.

The National Textile Workers Union sure puts up a fight for its members. All workers in the mills should join and support it. A Mill Worker.

U. S. Farm Expert Lies About Farm Wages

Walter C. Fulson, member of the Board of Agricultural Economics by his report on farm wages issued last week, announced that farm wages are good, and equal or exceed the average (sic) time and actual earnings of laborers in some industries.

This crack is about as humorous as Hoover's famous statement of a year ago that the "depression will be over in 90 days."

We invite Mr. Fulson to take a trip to Silver Creek, Georgia, and to ask the starving croppers on the big Bradshaw plantation what wages Bradshaw pays. If he does he will find hilly men working twelve hours a day for 50 cents a day with no board or room furnished.

Yes, these are "good wages"—for Mr. Bradshaw. A Charlotte Mill Worker.

T. U. U. L. L. RED CLASSES HELD

They are now living off hands due to the fact that there are no orders coming in.

Some workers have to stay in the mill all day long with only one loaf, which means about \$1.25 a day.

There is only one dinner and one water stand in the whole weave room. This is some system of sanitation. We workers wonder where the Charlotte Health officers are that are supposed to look after such things.

We also have a Lenin Corner in the Pinoca mill where we keep clippings and pictures from the workers papers pasted, such as articles from the Daily Worker, Southern Worker, Labor Unity, etc.

The boss doesn't care to pay anything about this. We also hold classes in Trade Union Work and Communism right in the mill during lunch hours.

Anyway we workers have learned not to expect anything from the capitalists and their government. We are now joining the NTWU and have had a good local of the NTWU here for some time.

We want other workers in the other mills to join. With us we all can tell the bosses where to get off. A Mill Worker.

Charlotte Mill Workers Get \$4 For 40 Hour Wk.

By A Worker Correspondent... We workers here in Charlotte, who have been stretched out and speeded up so much until we can hardly get up, have been handed another wage cut this week.

The Hosiery and sock mills employing about 400 workers have worked out a nice scheme to cut the wages of us workers. You find they are putting us on a 10 hour day with 6 1/2 hours for our skill (sic) days per week.

This means that we will work about 40 hours a week for \$4. The more we workers stand for this stuff the more the bosses will pile it up on us.

They can't give a damn about us and it is time we should know this and get busy and get a start to it.

We must all get together and organize and let the boss know that we want stand this slavery any longer. We must not be afraid of the boss. We don't have any jobs is one. If we don't work we starve and if we work we starve.

Workers get busy and organize. The National Textile Workers Union is the fighting union that has just won victories for the workers in Lawrence, Mass. And what they did there we can do here if only we get busy.

Every worker in the Textile mills must join the NTWU and fight like hell against the speed up and the wage cuts. A Charlotte Mill Worker.

Movie Whips Up Lynch Spirit Garment Workers Sold Out by AF of L

Having heard so much about the "Birth of a Nation" the motion picture and knowing it would be of interest to other workers to know what it meant, we went to see it. Its lesson comrades is indeed a serious one and one which every class conscious worker should understand and expose.

The picture itself was first shown in 1914 and is acclaimed by the boss press as the greatest film of all time. This picture deals with the South during and after the Civil War. It is calculated to foment the most intense Negro hating prejudices among those who see it—by portraying the poor Negro slaves who had been "freed" by the Northern capitalists, during the Civil War, as brutal savages whose greatest desire was to rape or marry a white woman. The picture shows how the Northern capitalists sent their agents, the carpetbaggers, down to the South to capture the Negro vote—to fool and deceive them. That to use them as tools against any resistance on the part of the Southern landlords to the policies of the Northern bosses. The murderous bloody KKK is pictured as the "Savior" of the South under the banner of the "Holy Cross" and such lies.

The significance of the widely heralded revival of this picture is of extreme importance at this time. Throughout the South this picture is playing—in Dallas, Texas, where our comrades were nearly lynched for fighting for the rights of both Negro and White workers against starvation. Its purpose is very plain. The Communist Party is rallying the masses of White and Negro toilers, workers and farmers, together for a joint fight against the starvation and misery of this rotten capitalist system and bosses are using this picture to stir up and arouse within the white workers of the South, especially—and of the North as well—the poison of race prejudice, to stir up a lynch mob spirit, to glorify and prepare the ground for the fascist KKK bands as present day "saviors," and thus smash the growing unity of white and Negro toilers against starvation, discrimination, and worsening conditions. The bosses feel well realize that the loss of employment, starvation, wage cuts, speed-up and bosses terror is forcing white and Negro workers together.

Further this picture shows that the capitalist, well and so using all means, press, radio, church, films and so forth in order to spread their propaganda and their racial poison. The crowd, mostly made up of bosses and small business men (as most workers sure couldn't afford the price) cheered and clapped to the vitriolous scenes.

Every class conscious worker—white and negro—must expose this latest most vicious attack on the Negro toilers and on the working class as a whole. Our answer must be increased organization into the ranks of all working class organizations—above all the Communist Party, and the wiping out of any trace of white chauvinism. Workers—rally your friends and shopmates to the mass Protest Demonstrations on March 28 against Lynchings, Deportations, and bosses' terror! Show the bosses the force of our organized protest against the near lynching of comrade Hurst and Coker in Dallas, Texas, and the bosses attempt to deport the militant worker Yonishen.

Atlanta, Ga.—2500 striking workers of the Marcus Ford General Co. went back to work Monday after an agreement was reached. The wage cut proposed by the company had been dropped by the company and the officers of the United Garment Workers Union. Such agreements to "arbitrate" any disputes was followed by a contract by the arbitration committee in favor of the bosses.

It is to be expected that due to the treacherous act of the union officials in ordering the strikers back to work and in submitting the dispute to arbitration, that a wage cut will be forced on the workers. The Trade Union Unity League in a leaflet distributed to the strikers had warned them against such a sell-out and had called on the workers to take control of the strike themselves and to carry it to victory.

Mexican Jobless Forced To Eat Grass Many Die

HERMOSILLO, Mexico.—The jobless workers of Hermosillo here have had a hard time getting a meal. At one time hunger was so bad they had to eat grass. They had no money.

A number of starving workers have died in this town recently from the effects of eating grass in a futile effort to save off starvation. These workers are principally Mexicans who have been deported from the United States. An American College professor recently recommended that the unemployed of this country eat alfalfa to avoid starving to death. But the workers of Mexico and the United States will not follow this "advice." They will continue to organize the struggle for unemployment insurance at the expense of the government and the employers.

M.W.I.L. Calls For Struggle

Chattanooga Enamel Works of Chattanooga are beginning a campaign of laying off workers in every department. Sixty were laid off last week and now the roll threatens to reach 100 within a month. This will add 150 workers to the already large number of unemployed in Chattanooga. The Metal Workers Industrial League has issued a leaflet calling on the workers to organize Shop Committees and Unemployed Councils.

Wage Cut In Exposition

The Exposition Mill will put a wage cut of fifteen per cent on the workers this week. This mill ordinarily hires 2500 workers and now has only 500 on the job. The terrible degree of poverty in which the workers of the Exposition Mill have been thrust can be judged by the fact that every single retail store within five blocks of the mill have either moved or gone bankrupt. The workers of the mill must peddle fruit in the streets in order to keep alive.

STARVING FARMER KILLS SELF

RUTHERFORDTON, N. C.—Facing starvation with a family of six to feed, R. Coy Price, 25 year old white farmer, killed himself with a shotgun. A few days ago he told his wife it was as much as he could do to keep from killing himself, so worried was he where the next days food would come from.

DePRIEST SHOWS HIS TRUE COLORS

Then this traitor attacked the Negro people finished his speech with an attack on the Soviet Union. "Don't listen to the dope you hear about Russia," he said. "The Russian people are suffering and good old America is the best country in the world."
